#### Welcome and Call to Order

Chair Marianne Radcliff called the meeting to order at 12:32 p.m.

#### **Public Comment Period**

Chair Radcliff solicited public comments. There were none.

#### **Approval of Minutes**

Chair Radcliff requested approval of the December 6, 2023, and March 6, 2024, meeting minutes. A motion was made by Ms. Chenery and seconded by Mr. Hewa, and the minutes were unanimously approved as presented.

#### **General Assembly Update**

Ms. Nicole Riley provided an update on the upcoming federal elections, reconvene session, and special session.

This November, 1 U.S. Senate and 11 U.S. House of Representatives seats are on the ballot.

#### **Key dates for the upcoming General Election:**

- June 18, 2024 Primary Election Day
- September 20, 2024 First day of absentee and in-person early voting
- November 2, 2024 Last day of in-person early voting

• November 5, 2024 – General Election Day

Ms. Riley gave a brief overview of primary candidates for the general election.

Ms. Riley reviewed legislative proposals of interest from the 2024 General Assembly session and their outcomes. The following eleven initiatives were signed into law.

The General Assembly returned to Richmond on May 13, 2024, for a Special Session to finalize the budget. Below are additional items of interest:

- 3% state raises for teachers, state employees, and support staff for each year of the biennium.
- \$2.5M in the second year (FY26) for the continuation of the Inland Port development led by the Virginia Port with VEDP support to include a business recruitment strategy for the inland port.
- \$3.95M (FY25) and \$5.25M (FY26) to expand access to high-demand credentials through increased funding for the Workforce Credential Grant
- \$1.50M in the first year (FY25) to support the transition of the workforce programs to the newly established Department of Workforce Development and Advancement
- \$90M over six years to increase Transportation Partnership Opportunity Fund (TPOF) funding to address infrastructure needs of large economic development-related projects.
- \$10M in the first year (FY25) to establish the Virginia Clean Energy Innovation Bank to finance climate initiatives within the Department of Energy. Up to \$2,000,000 of these amounts may be used for administration.

#### **Closed Session**

A motion was made by Ms. Chenery and seconded by Mr. Stone to move into a closed meeting. The members unanimously approved the motion shown below.

I move that the Legislation and Policy Committee of the Virginia Economic Development Partnership Authority convene a closed meeting to discuss elements of VEDP's Strategic Plan,

Marketing Plan, and Operational Plan pursuant to Subdivision A 50 of §2.2-3711 of the Code of Virginia, which allows for the discussion of such activities that would reveal to Commonwealth's competitors for economic development projects the strategies intended to be deployed, thus adversely affecting the financial interests of the Commonwealth.

#### September

■ 9/20 – Early voting begins

#### **October**

- 10/15 Deadline to register to vote or update an existing registration<sup>1</sup>
- 10/25 Deadline to apply for an absentee ballot

#### **November**

- 11/2 Last day of in person early voting
- 11/5 Election day



<sup>1</sup>Voters may register after this date, through Election Day, and vote using a provisional ballot
